

The US-Israel War Against Iran

The Need for a New Economic Model

What follows is a plausible, multi-layered geo-political hypothesis, intended to stimulate and facilitate respectful dialogue about the War against Iran.

Hypothesis:

Outer Layer: The current US/Israel war against Iran is not being waged simply because the US and Israel feel militarily threatened by Iran (including the threat of Iran developing nuclear weapons) or because the US and Israel believe the Iranian people and the world would be better off with “regime change” in Iran. Nor is it simply about oil. Nor is it just about Trump, or Netanyahu. It is deeper than that.

Second Layer: At a deeper level, it is also a war between a rapidly declining unipolar global capitalist system (led by US/Israeli) and a rapidly rising multipolar capitalist alliance (BRICS+, of which Iran is a vital member, but which is primarily led by China).¹

The US/Israel have started this war as a desperate effort to sustain the unipolar global capitalist system, which they have been controlling (to their great benefit), and to thwart the rise of BRICS+, particularly China. They are trying to do this by creating a “Greater Israel” that will take control of West Asia (which has necessitated the destruction of Iraq, Syria, Lebanon, and now Iran) and by controlling the Western Hemisphere (which has necessitated taking over Venezuela, Cuba, and South America), with one intention being to keep China and Russia out of these locations.

Third Layer: But it is actually much deeper and more sinister than the above. We need to realize that there is a consortium of ultra-wealthy, supra-national, ultra-capitalists (the most powerful members of the Davos/World Economic Forum group, which we will call the “Consortium” for short) who have captured immense power in the world over the past several decades.¹ Collectively, this Consortium has more than \$50 trillion US dollars at their disposal to create a world to their liking.² They envision a new hideously technocratic global governance, controlled by them, that will protect their interests, but will subject the rest of the world’s people to severe austerity and totalitarian/fascist control. They have the wealth, power, technology, connections, and the sick desire for complete control that are necessary to make this happen.

An escalating war between the unipolar global capitalists and the BRICS+ capitalists could be the pretext for the leaders of this Consortium to eventually “step in” to stop the war (which by then will have escalated into WWII with global economic collapse and potential nuclear disaster), bring “peace,” and implement the Consortium’s sick vision of a new global governance (the hideously technocratic autocracy).

But it is even more sinister than that. The escalating war between the US/Israel and Iran has possibly been planned all along to be the pretext for the Consortium to step in and impose their solution (a new global governance conceived by and controlled by them). It is conceivable that many of the current “leaders” of nations have been unwittingly (i.e., naively and possibly with good intentions) or wittingly collaborating with the Consortium’s plans. Trump and Netanyahu in particular, but also Macron, Carney, Merz, Starmer, Von der Leyen, other EU leaders, Modi, and Erdogan, may be consciously (largely) or unwittingly playing designated roles, on behalf of the Consortium.

Perhaps the role of Trump and Netanyahu has been to deliberately start wars and create chaos that will result in WWII and global economic collapse. Contrary to his claim to be “making America great again (MAGA),” Trump’s role has seemed to be the opposite---to transform the USA into a weak, failed state---by fueling hostile division among citizens, ignoring national and international laws, coarsening discourse and culture, modelling vulgarity and criminality himself, creating insurmountable public and private debt, destroying the American economy (except for the already ultra-wealthy), and preparing the American public for severe austerity and fascism.

It is hard to believe that Trump would “throw the American people under the bus” and make such obvious and huge mistakes regarding Iran, if he were not envisioning an eventual huge reward from the Consortium. Likewise, it is hard to believe that Netanyahu would order genocide and then start a losing war against Iran, if he were not expecting some huge eventual reward from the Consortium. As a small example, both Trump and Netanyahu can hardly wait for the eventual rebuilding of a resort-laden Gaza-by-the sea. It makes sense, too, that the Consortium would choose people like Trump and Netanyahu to execute the Consortium’s plans---because it takes immoral, wealth-seeking men with little or no consciences to execute such plans.

It is possible that ultra-capitalist billionaires in China and Russia are also involved in these plans. They may be waiting in the wings, ready to step in after timely regime change. Their current roles could be to encourage China and Russia to passively stand by, while warning that the war against Iran could easily escalate to WWII and nuclear disaster. In the meantime, China, in particular, has been developing technologies and mechanisms of social control that will be useful to the Consortium.

The hypothesis goes on to suggest that when the time is right—i.e., when WWII is well underway, global collapse is nearing Great Depression levels, and nuclear disaster seems imminent—the Consortium will step in and offer to “save the world” and bring peace. A terrified, mis-informed, and desperate global public (or at least much of it) will accept the Consortium’s offer because they will see no other realistic option and they will buy into the Consortium’s claim that they are the only ones, realistically, who have the competence, wealth, power, and network connections to prevent nuclear holocaust and quickly bring peace and better governance to the world.

The Consortium will immediately order Trump and Netanyahu to stop their wars in Gaza, Iran, and elsewhere. Trump and Netanyahu will immediately obey. Zelensky and his European supporters will be ordered to stop the war in Ukraine, and they will comply. The Consortium will then use its immense wealth and its network of obedient leaders to rebuild Gaza, Ukraine, Syria, Iraq, Lebanon, Iran, and other countries--- transforming these war-torn countries into techno-capitalist “miracles.” The Consortium will also use its immense wealth and connections to rebuild the global economy, to their liking, of course. Global chaos will greatly diminish because the Consortium will no longer need to deliberately create chaos as a means to its goals. Trump, Netanyahu, Carney, Macron, Von der Leyen, Merz, Starmer, Erdogan, Modi, and billionaires in China and Russia will be handsomely rewarded for playing their roles. Some of them will play prominent roles in the Consortium’s New Global Governance.

So, when we peel back the multiple layers, we realize that the US-Israel war against Iran is mostly about the Consortium and its plans for a hideously technocratic, ultra-capitalist, totalitarian form of global governance, controlled by the Consortium and the compliant leaders they have placed in countries throughout the world.

The Deepest Layer: But there is one more layer. The Consortium, with its immense wealth and power, exists in the first place because of the corporate capitalist economic model itself. The predictable and inevitable outcome of the corporate capitalist model is that those who most aggressively, ruthlessly, and diabolically practice the model (exemplified by the small group of supra-national ultra-capitalists) will accrue immense wealth, power, and control over others. In other words, the Consortium and its plans are the predictable outcome of the corporate capitalist model.

So, when all the layers are peeled away, we see that **the corporate capitalist economic model is at the core of the war against Iran**, and we realize that the best way to stop this war, prevent escalation of it into WWII, prevent Great Depression-level global economic collapse, prevent nuclear disaster, and prevent the Consortium from successfully implementing its plans for a hideously technocratic totalitarian form of

global governance is to: a) critically examine and expose the corporate capitalist model, including the Consortium that it has predictably spawned; and b) provide a compelling alternative economic model that the majority of the world's citizens can come to understand and embrace---a model that creates Kind Social Arrangements and Social Beauty,³ rather than the Mean Social Arrangements and Social Atrocity that the corporate capitalist model, by nature, tends to create.

The above multi-layered hypothesis about the war against Iran will be readily dismissed by many as “conspiracy theory” or at least “going too far.” But there certainly are nefarious people in the world, and, unfortunately, many such people have become enormously wealthy and powerful, thanks to the prevailing economic model (globally practiced corporate capitalism). Why would we trust the giant global asset management firms and the billionaire leaders of the World Economic Forum? Why do we think people like Trump and Netanyahu, who shamelessly kidnap and assassinate leaders of other countries and carry out genocide, all with impunity, could not be part of a nefarious global plan? Why do we think obscenely wealthy and heartless leaders of the Consortium could not concoct such a global plan? It is wise to carefully consider all plausible hypotheses. Openminded analysis gives us the best chance to recognize and thwart what is happening.

The hypothesis shared in this article may not be entirely accurate. Regardless, it is essential that the general public engage in healthy, respectful dialogue about the root causes of the horrible global events that are unfolding. In particular, such dialogue could explore the possibility that the corporate capitalist economic model, itself, is a major root cause of the problems facing Humanity. Is it unfair to suggest that the “Consortium” is a predictable outcome of the corporate capitalist model? Is it unreasonable to suggest that the sequence of global events could be reflections of the Consortium’s goals and the Consortium’s efforts to achieve those goals?

Dialogue could also be focused on solution. If the corporate capitalist model has been a major root cause of the many problems facing Humanity, then what alternative economic model would be better? It is not enough to just criticize the status quo and the current prevailing economic model; it is essential to consider an alternative social and economic model.

To stimulate, facilitate, and inform such dialogue, I have written a book entitled ***Sowing Seeds of Social Beauty---The Untold Story of the Children’s Hospital Public Economy Model (CHPEM)***. The book contends that a major root cause of the problems facing Humanity (including wars between capitalist alliances) is the corporate

capitalist model itself, and a possible solution is an innovative public economy model (e.g., the CHP⁴) that creates “vast fields of public activity.”

If/when the Consortium steps in and offers its plan for global governance, we need to be prepared to not only say, “No,” but also to present an alternative plan for the world’s people to consider. Better, yet, if we act quickly, now, to mobilize massive public dialogue about the issues raised in this article and dialogue about an alternative economic model (like the CHP⁴), we might be able to stop the war against Iran and stop the Consortium’s plans before WWII evolves, before further global economic collapse occurs, and before nuclear disaster occurs. Such a solution, however, will require open-mindedness, respectful dialogue, and a massive educational effort. If we do not engage in such dialogue, the status quo will worsen and we may find ourselves severely oppressed by hideously technocratic totalitarian/fascist global governance, assuming we have not already been annihilated by nuclear holocaust.

SUMMARY:

A Multi-layered Hypothesis regarding what the War against Iran is about:

Outside Layer:

Perception that Iran represents a military threat (with potential nuclear arms) // Perception that regime change is necessary // Oil // Trump // Netanyahu

Second Layer:

A war between a rapidly declining Unipolar Global Capitalist System and a rapidly rising Multipolar Global Capitalist Alliance (BRIC’s+)

Third Layer: The plans of a “Consortium” of ultra-wealthy, supra-national, ultra-capitalists.

Deepest Layer: The corporate capitalist economic model that has predictably spawned the Consortium, or has at least spawned a battle between the Unipolar capitalists and the Multipolar capitalists. .
